Mr. Carreras,

As a part of the State's 2024-2025 General Appropriations Bill, the budget for the Office of the Adjutant General included Pass Thru funding designated for "National Medal of Honor Center for Leadership" in the amount of \$5,000,000.

The funds were provided to the National Medal of Honor Center for Leadership in accordance with the procedures as outlined by Proviso 117.21. (Organizations Receiving State Appropriations Report) and the Governor's Executive Order 2022-19.

The Center provided quarterly reports to the Agency for FY25. However, the Center did not fully execute the funds within the State FY and is required to continue to provide quarterly reports until all funds are executed.

Attached is the Earmarked Appropriation Expenditure Report for the National Medal of Honor Center for Leadership for the 1st Quarter (Jul - Sep) of State FY 26.
